Provisions Relating to Debts and Obligations

4. That no debts were incurred during the course of the marriage.
5. The parties should be held liable for any debts or obligations entered into after the date of separation.

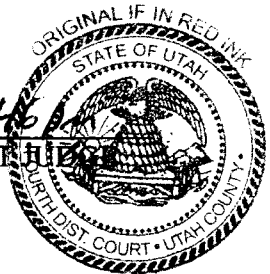
Miscellaneous Provisions
