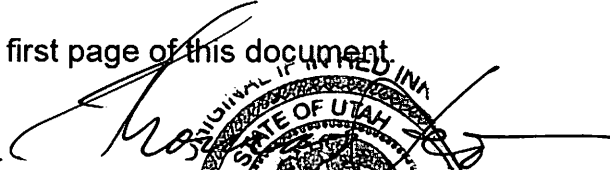

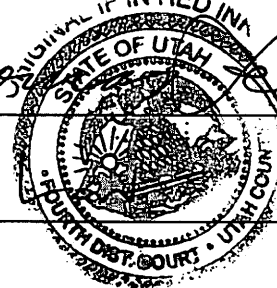
8. The parties do not need a court order about retirement money.
