plus interest on the total Judgment to accrue at the rate of 9.74% per annum from July 23, 2025, until paid in full, plus costs accruing after Judgment

On Plaintiff's Fifth Cause of Action:

Principal amount	\$2,315.27
Interest at the rate of 15.25% per annum from December 6, 2023, to and including July 22, 2025	\$576.24
Judgment Amount	\$2,885.51

plus interest on the total Judgment to accrue at the rate of 15.25% per annum from July 23, 2025, until paid in full, plus costs accruing after Judgment
