Pursuant to the Court's Order From Hearing on June 18, 2026, regarding Petitioner's objections to Respondent's requests for attorney fees, and the Court having ruled that the attorney fee request in Docket No. 253 be reduced by 1.0 hour and the attorney fee request in Docket No. 306 be reduced by 1.5 hours, the Court enters the following Judgment:

1. Docket No. 253 (Respondent's Motion to Enforce and Request for Sanctions and Fees heard February 27, 2026):

- a. Requested attorney time: 13.5 hours.
- b. Reduction ordered by the Court: 1.0 hour.
- c. Approved attorney time: 12.5 hours.
- d. Hourly rate: \$337.50 per hour.
- e. Attorney fee award: \$4,218.75.

2. Docket No. 306 (Respondent's Motion to Enforce and Request for Sanctions and Fees heard May 13, 2026):

- a. Requested attorney time: 16.2 hours.
- b. Reduction ordered by the Court: 1.5 hours.
- c. Approved attorney time: 14.7 hours.
- d. Hourly rate: \$337.50 per hour.
- e. Attorney fee award: \$4,961.25.

3. Total attorney fee award:

$\$4,218.75 + \$4,961.25 = \$9,180.00.$

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that Respondent Kelly Ronald Storrs is awarded judgment against Petitioner Amanda Amber Storrs in the amount of **NINE THOUSAND ONE HUNDRED EIGHTY DOLLARS (US\$9,180.00).**

This judgment shall bear interest at the statutory judgment interest rate from the date of entry until paid in full.
