It is **FURTHER ORDERED**, pursuant to Rule 73 (d), U.R.C.P., that this Judgment may be augmented after further order of the court in order to add any amount expended by Plaintiff for attorney's fees that arise from considerable additional efforts in collecting or defending the judgment. Accordingly, in the future, Plaintiff may file additional Motions, supporting Affidavits and evidence with this court showing justification for augmentation of this Judgment that may be awarded to Plaintiff against Defendant Kellie Blackhurst.
