The court decrees:

### Divorce

1. Corina Aaron-Silva is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Corina Aaron-Silva. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Corina Aaron-Silva** and **Marcio Rodrigues Da Silva** do not have any children together.

- We are not expecting a child.

### Real property

5. The parties do not have any real property that is marital property. The parties do not need a court order about real property.

### Alimony

6. Neither party will pay alimony.

### Retirement money

7. The parties do not need a court order about retirement money.

### Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

### Name after divorce

9. **Corina Aaron-Silva** changed **her** name when the parties married. **CorinaAaron-Silva's** name will be **Corina Aaron** after the divorce.
