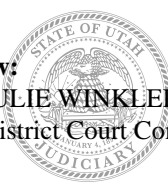

This matter having come before the above-entitled court for a hearing on May 19, 2025, the Honorable Commissioner Julie Winkler presiding. Lavon Jackson (Lavon”) being present with counsel, Adam S. Kawaguchi, and Michael Jackson (“Michael”) being present pro se. The Court having heard argument, reviewed the orders and related information and being fully informed hereby makes the following order:

1. Pursuant to the *Order on Motion to Enforce Domestic Order and Judgement (Hearing May 19, 2025)* entered on March 27, 2026, the Court awarded attorney fees and costs to Lavon for the work related to the *Motion to Enforce Domestic Order and for Sanctions* filed on April 7, 2025.
2. Counsel for Lavon filed an *Affidavit of Attorney Fees* on March 26, 2026.

3. Michael did not file an Objection to Affidavit of Attorney Fees.

4. The Court finds that the rates of Lavon Jackson's counsel, Adam S. Kawaguchi, is consistent with other attorneys practicing in the area and with his experience.

5. As a result, the Court orders that Michael pay to Lavon's attorney fees and costs in the amount \$3,829.50.

~~6. Judgment is, therefore, entered in favor of Lavon and against Michael in the amount of \$3,829.50.~~

~~7. Pursuant to Utah Code § 15-1-4, the statutory post-judgment interest rate of 5.51% shall be applied to the judgment until the judgment has been satisfied.~~

~~8. If the judgment has not been satisfied within thirty (30) days of the entry, the debtor, Michael, shall be responsible to pay after-accruing costs and attorney fees expended by Lavon in the collection of said judgment.~~
