Additional provisions

10. The parties will adhere to the following additional provisions:

a.

Additional Provision: The parties agree that the Respondent shall pay the Petitioner a lump sum of 13628.74 for debt equalization no later than 60 days after the divorcee decree is finalized. The payment is 50% of the remainder of the petitioner's and the respondent's marital debt. Respondent's obligation is limited to the lump-sum payment described above.

Duty to sign documents

11. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

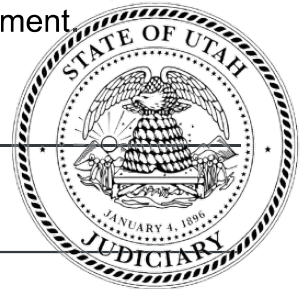
