The above-entitled matter came before the Court upon the issue of attorney's fees and costs previously awarded to the Petitioner pursuant to the *Decree of Divorce* entered on April 29, 2026.

As directed by the Court, the Petitioner, Marianne Rushton, through her counsel of record, Cory R. Wall, submitted her *Affidavit of Attorney's Fees and Costs* on May 1, 2026, detailing the attorney's fees, paralegal fees, and costs incurred in connection with this matter.

The Court, having reviewed and considered the Petitioner's *Affidavit of Attorney's Fees and Costs*, the itemization of attorney time, paralegal time, and litigation expenses,

the absence of any objection or response from the Respondent, and being otherwise fully advised in the premises, finds that the attorney's fees and costs incurred by the Petitioner are necessary, fair, and reasonable under the circumstances of this case. The Court further finds that the Petitioner incurred attorney and paralegal fees totaling \$3,195.26, and costs and expenses totaling \$952.25, for a combined total of \$4,147.51.

WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. Judgment is entered in favor of the Petitioner, Marianne Rushton, against the Respondent, Terry Wesley Rushton, in the amount of **\$4,147.51**, as and for the Petitioner's attorney's fees and costs associated with her *Verified Petition for Divorce*.
2. This Judgment shall accrue statutory interest from the date of entry until paid in full.
3. The Petitioner may pursue all lawful means of collection and enforcement of this Judgment.
