Petitioner having filed a Petition for Divorce and the parties having reached a final resolution by filing a Stipulation resolving all issues; **and the Court having previously entered its written Findings of Fact and Conclusions of Law; NOW THEREFORE IT IS HEREBY ORDERED ADJUDGED AND DECREED AS FOLLOWS:**

JURISDICTION AND VENUE

1. The parties were actual and bona fide resident of Davis County, State of Utah for the 90 days preceding the filing of this action. See Utah Code §81-4-402(1)(a).
2. The parties have no minor children, and none are expected.

3. The Petitioner and Respondent are husband and wife, having been married on March 19, 2016, in Weber County, Utah.

GROUND

4. During the course of the marriage irreconcilable differences have arisen that render it necessary to dissolve the marriage. The parties are granted a divorce on the grounds of irreconcilable difference.

REAL PROPERTY

5. The home and real property ("Home") located at 373 W. 2300 S., Clearfield Utah, is awarded to Joseph. Joseph is also assuming all liability, debt and encumbrance associated with the same. Joseph shall hold harmless and indemnify Justine from any liability, debt and encumbrances associated with the same. Joseph shall pay Justine \$35,000 as her portion of the equity, within 30 days of the parties' signatures below. Additionally, Joseph will pay Justine an additional \$110,000 over 6.5 years at 4% interest (72 months) at a rate of \$1,600 per month. Joseph may pay the total amount off early.

PERSONAL PROPERTY

6. Joseph is awarded the personal property currently in his possession including his pre-marital vehicle and the parties' two dogs. However, Justine may take Hazel when she feels well enough to care for the dog.

7. Justine is awarded the personal property currently in her possession.

8. That any other marital property shall be equitably divided between the parties. If the parties are unable to agree to further distribution, then the parties shall mediate any dispute thereto prior to bringing the action before the court.

BANK ACCOUNTS/BUSINESS

9. Joseph is awarded the bank accounts, financial or other assets currently under his control.

10. Justine is awarded the bank accounts, financial or other assets currently under her control.

11. Any other accounts/financial assets shall be equitably divided between the parties. If the parties are unable to agree to further distribution, then the parties shall mediate any dispute thereto prior to bringing the action before the court.

DEBTS

12. The parties shall pay any and all debts incurred in their individual name.

13. That any and all debt not disclosed or divided herein shall be the exclusive responsibility of the party that incurred the same regardless of whether used for marital benefit.

14. The payment of the debts set forth above is non-dischargeable in bankruptcy, solely as to the indemnification of the other party.

RETIREMENT BENEFITS

15. The parties are awarded their respective retirement accounts free and clear of any interest in the other.

ALIMONY

16. No alimony is awarded to either party whether past, present, or future.

MAIDEN NAME

17. Justine is restored to her maiden name of Saxton, if she so desires.

ATTORNEYS FEES:

18. Each of the parties shall pay their own attorney fees and court costs.

19. If either party defaults in his or her obligation hereunder or must seek relief from the Court in the enforcement of the Decree of Divorce, the non-prevailing party should be liable to the other party for all reasonable expenses, including attorney fees and court costs actually incurred.

BENEFICIARY DESIGNATION

20. Any life insurance, stock, bond, title, retirement, investment, or other governing instrument, wherein the parties are listed as the other party's beneficiary or shall receive benefit, such designation is hereby revoked. The parties shall not receive beneficial interest in any of the foregoing. See Utah Code Ann. § 75-2-804(2).

TRANSFER OF PROPERTY/NOTICE TO CREDITORS

21. Each party shall immediately deliver all property awarded to the other party in their possession and execute all documents/titles necessary to effectuate a property transfer as set forth herein, including automobile titles, tax forms and/or any other instrument necessary to carry out these terms.

22. Each party shall immediately notify their respective creditors of these terms, the party obligated to each specific debt and make other such reasonable arrangements to implement these terms.

23. Unless otherwise agreed the foregoing shall be completed within 60 days of the entry of the Decree of Divorce.
