The court decrees:

Divorce

1. Makenna Rayleigh Martin is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Makenna Rayleigh Martin. The divorce will become final upon entry of the divorce decree.

6. This other property will be divided as follows:

The parties acknowledge ownership of three cats: Harold (domestic shorthair, DOB 04/15/2023), Mavis (domestic shorthair, DOB 06/02/2024), and Billie (domestic shorthair, DOB 08/16/2024). Makenna Martin is awarded sole and exclusive ownership and possession of all three cats listed above. Makenna Martin shall be solely responsible for all expenses related to the care of the cats, including but not limited to food, supplies, and veterinary care. Steven Johnson shall have no ownership interest in, nor any right to possession of or visitation with, the three cats listed above.

d.

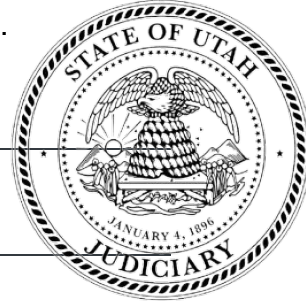

Duty to sign documents

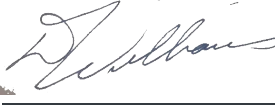
13. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days,

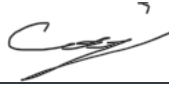
