Having previously entered its Findings of Fact and Conclusion of Law, the Court hereby enters this Decree of Annulment based upon the agreement of the parties executed on May 15, 2026.

**THE COURT THEREFORE ORDERS, ADJUDGES AND DECREES AS
FOLLOWS:**

The parties are granted an annulment. The following terms apply.

A. Children.

1. The parties have no minor children.

B. Alimony.

2. The parties have been gainfully employed during most of the marriage and the marriage was of very short duration. No alimony shall be awarded.

C. Personal Property.

3. During the course of the marriage relationship, the parties acquired very few items of personal property and have already divided most of their property but agree to the following:

- A. Liz: Her personal effects and clothing, all items of personal property in her possession, except items promised to Jack in B below, and her vehicle.
- B. Jack: His personal effects and clothing, all items of personal property in his possession, all vehicles in his possession with the obligation to any loans upon such vehicles. Jack is awarded an iPhone currently in possession of Liz, which shall be delivered within seven (7) days of execution of this document. Jack shall be awarded all rights related to an Apple Watch which was in the possession of Liz but which she believes to have been lost or stolen (should Liz locate it she shall deliver it within seven 7 days; shall any statement or information about its loss be needed and requested she shall provide it within seven (7) days of a request through counsel).
- C. Any remaining items not specifically addressed herein shall be divided as agreed upon by the parties.

D. Real Property / Business Interests

4. The parties have acquired no real property or business interests during the marriage.

E. Financial Debt

5. The parties shall each be responsible for debt in their own name.
6. Jack shall pay any debt upon the 2024 Subaru Forester and retain possession of the same.

F. Retirement

7. The parties shall each keep their own retirement accounts, if any.

G. Retirement

8. The parties shall sign all documents necessary to comply with the Decree within twenty-one (21) days of any written request from the other party.
