The Plaintiff was represented by, G Scott Jensen of the law firm of JENSEN & SULLIVAN LLct. The Defendant was present, but not represented by counsel. The parties entered into a stipulation in open court, as indicated in the Court's minutes.

THE PARTIES AGREED TO THE FOLLOWING:

1. That the Plaintiff be awarded judgment against the Defendant for the sum of \$17,900.00 which is inclusive of \$17156.67 in principal, \$425.00 in court cost and \$318.33 in attorney's fees; as prayed for in the complaint.
2. That interest on the total at the rate of 6.23% per annum pursuant to Section 15-1-4 U.C.A. from the date of this judgment until paid.
3. The defendant is to pay \$300.00 per month commencing May 20, 2026, and on the 20th of each month thereafter until paid in full.
4. Plaintiff agreed to forego executing on post judgment remedies as long as the defendant makes the payments when due.
