## Divorce

1. Aimee Sharee Wathen is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Aimee Sharee Wathen. The divorce will become final upon entry of the divorce decree.

Children (Utah Code 81-6-101(7))

2. **Aimee Sharee Wathen** and **Conor Steven Wathen** do not have any children together.

- We do not have any children together who are minors. A minor is a child under 18 who has not been married or otherwise emancipated.
- We are not expecting a child.
- We do not have incapacitated adult children together who are eligible for child support, or, **Aimee Sharee Wathen** is not asking for child support for any adult child who is eligible for child support.

This includes signing any forms needed for release of the information to the other party (Alternate Payee).

8. If the Plan Participant receives any retirement money awarded to the Alternate Payee, the Plan Participant receives that money in a constructive trust for the Alternate Payee. The Plan Participant is ordered to pay the benefit directly to the Alternate Payee within 5 days of its receipt. Information on the pension plans and how they are to be divided is listed below:

### Name after divorce

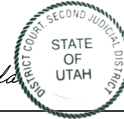
