This matter came before the Court on May 29, 2026, regarding the Private Guardian ad Litem's *Motion for an Order and Judgment Assessing Fees and Expenses*. Petitioner Bryant Smith was present and represented by counsel of record, Kaitlyn Gibbs. Respondent Candice Smith was present and represented by counsel of record, Chase Walker. Celia Ockey, the Private Guardian ad Litem ("PGAL"), was present. Based upon the stipulation of the parties and good cause shown, **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:**

1. The Private Guardian ad Litem's *Motion for an Order and Judgment Assessing Fees and Expenses* is hereby granted. Judgment is entered in favor of the Private Guardian ad Litem, Celia H. Ockey, in the amount of \$31,361.60 for which Respondent, Candice Smith, is responsible.

2. The PGAL's fees may be reallocated at trial.

3. Candice shall make payment to the PGAL for fees and expenses going forward.
