9. The parties will adhere to the following additional provisions:

a.

Additional Provision: **Kenneth J Trujillo and Shannon N Trujillo have been physically separated since September of 2019. Since that time, all mutual assets have already been divided, including all mentioned vehicles, with the exception of the equity in the home. Shannon will remain in the home and assume the mortgage, giving Kenneth his agreed upon equity once divorce is final and title is clear for Shannon to refinance the mortgage. A quitclaim deed will be submitted to remove Kenneth from the title of the property. Both Shannon and Kenneth worked full time throughout the marriage and will retain their own individual pension and/or retirement accounts. Both Parties will go to DMV to have vehicle titles assigned to individual owners stated earlier in this interview.**

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

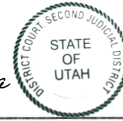
