The court decrees:

Divorce

7. The parties do not need a court order about retirement money.

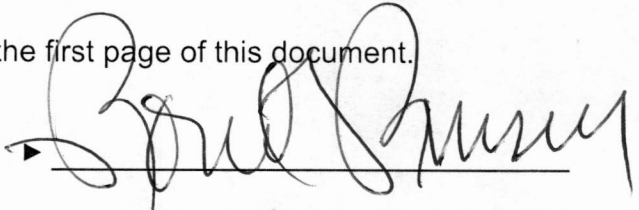
Duty to sign documents
