The court decrees:

Divorce

1. Jonathan Adam Pocock is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Jonathan Adam Pocock. The divorce will become final upon entry of the divorce decree.

Additional Provision: **Jonathan Adam Pocock has no claim on any assets (Retirement, Pension, Bank, Real Property, Personal Property) belonging to Blithe Elizabeth Cravens (including any trust or business interests) and Blithe Elizabeth Cravens has no claim on any assets (Retirement, Pension, Bank, Real Property, Personal Property) belonging to Jonathan Adam Pocock (including any trust or business interests).**

Duty to sign documents

9. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days,

the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
