IN THIS ACTION, Defendant Bryan W. Hyde (the “Defendant”), having been served with process and having failed to appear and answer Plaintiff Goldenwest Federal Credit Union’s Complaint on file herein, the legal time for answering having expired, and the default of the Defendant having been duly entered according to law, now upon application of Plaintiff to the Court, JUDGMENT IS HEREBY ENTERED as follows:

1. Judgment is hereby entered in favor of the Plaintiff and against the Defendant for the amount due and owing to Plaintiff under the Note, as such term is defined in the Complaint,

which is \$20,494.79, plus interest at the contract rate of 7.99% from April 30, 2026, until paid in full;

2. Judgment is hereby entered in favor of the Plaintiff and against the Defendant for the amount due and owing to Plaintiff under the LOC, as such term is defined in the Complaint, which is \$954.76, plus interest at the contract rate of 15.9% from April 30, 2026, until paid in full;

3. Judgment is hereby entered in favor of the Plaintiff and against the Defendant for the amount due and owing to Plaintiff under the Negative Shares, as such term is defined in the Complaint, which is \$1,123.46, plus prejudgment interest at the statutory rate of 10% from April 30, 2026, until the date hereof, and post-judgment interest thereafter at the statutory rate until paid in full;

4. Judgment is hereby entered in favor of the Plaintiff and against the Defendant for attorney's fees of \$1,368.00 and costs of \$434.30;

5. The total judgment awarded to the Plaintiff against the Defendant, excluding prejudgment and post-judgment interest is \$24,375.31; and

6. It is further ordered that this judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting the judgment by execution or otherwise, as allowed by statute or rule and approved by the Court.
