THIS MATTER came before the Court on Petitioner's Statement of Attorney Fees and Respondent's Objection thereto. A hearing was held on April 1, 2026, the Honorable Judge L. Douglas Hogan presiding. Petitioner, Amanda Grace Faulkner ("Amanda"), was present via Webex and was represented by her attorney, Michael Mickelson, of Caldwell Filler & Grayson. Respondent, Scott D. Garcia, ("Scott") was present via Webex and was represented by his attorney, Matthew Olsen. The Court, having reviewed the filings made herein, heard proffered testimony and argument, and having made findings and orders on the record, and now, being fully informed in the premises and for good cause appearing, the Court hereby enters the following orders:

1. Attorney Fees. Respondent shall be responsible for 70% of Petitioner's attorney fees and costs incurred herein, as stated in her *Statement of Attorney Fees* (docket #105). The total

amount is \$11,068.92. Therefore, Petitioner is awarded attorney fees against Respondent in the amount of \$7,748.24 (11,068.92 x .7).

2. A judgment shall be entered against Respondent in the amount of \$7,748.24, and this judgment shall accrue interest at the statutory rate until such time that the judgment is satisfied in full. Furthermore, this judgement of attorney fees may be filed as a lien against real or personal property in Respondent's name, or enforced in any other way allowed by law.
