**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that Plaintiff Freedom Solar Pros, LLC, is awarded judgment against Defendant Ammon Makisi Fifita in the confessed

amount of **\$220,000.00**, plus pre-judgment interest at the rate of 10% per annum pursuant to the parties' contract from February 17, 2025 through January 14, 2026, totaling **\$19,950.68**, for a total judgment amount of **\$239,950.68**.
