Divorce

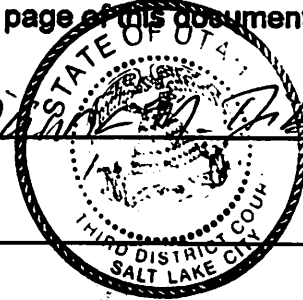
