Divorce

Upon finalization of the divorce, possession of the vehicle shall be returned to Grant Ross, and Wildelena Ross shall relinquish use and possession of the vehicle at that time.

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)


