**JUDGMENT AFTER JURY TRIAL OF  
MARCH 4, 2026**

Case No. 230902132

This matter came before the court on March 4, 2026 for a jury trial. The Honorable Richard Pehrson presided over the trial. The issues have been duly tried before the court and the jury, and the jury has rendered its verdict. The jury duly found that:

1. Defendant Ronald Ady failed to use the same degree of care, skill, judgment and diligence used by reasonably careful attorneys under similar circumstances in his representation of Brandon Stuber in a prior lawsuit;
2. Such failure to use that degree of care was the cause of Brandon Stuber's harm;

3. Ronald Ady (i) took improper advantage of his superior legal knowledge and position in his representation of Brandon Stuber, (ii) failed to have undivided loyalty to Brandon Stuber, (iii) concealed important facts or law from Brandon Stuber, or (iv) deceived Brandon Stuber;

4. Ronald Ady's conduct was a cause of Brandon Stuber's harm; and

5. The amount of damages suffered by Brandon Stuber related to the foregoing is \$5,730.04.

WHEREFORE, THIS COURT ORDERS, ADJUGES, AND DECREES that Plaintiff shall recover from and judgment in favor of the Plaintiff is hereby entered against Defendants Ronald Ady and Ronald Ady PLLC, jointly and severally, for the sum of \$5,730.04, plus prejudgment interest of \$1,918.57 and costs allowed under Rule 54 Utah R. Civ. P. of \$375.00 for filing the complaint, \$35.00 for service of process of the summons and complaint, \$1,609.43 for the deposition of Defendants, and \$18.50 in expert witness fees, for a total judgment of \$9,686.54, with interest on the total judgment at the legal rate of 5.51% per annum after the date of this judgment pursuant to Utah Code § 15-1-4.
