7. Additional Orders

Petitioner Erik Perez is awarded sole legal custody and sole physical custody of the minor child E.P.A., born December 24, 2023. Parent-time for Respondent is suspended until further order of the Court.

The Court finds that the minor child, E.P.A., whose home state is Utah, was removed from the State of Utah by Respondent without Petitioner's knowledge or consent. Respondent has failed to return the minor child to Utah despite the Court's prior Temporary Emergency Order entered December 2, 2025.

Respondent was properly served with the Summons and Amended Verified Petition for Divorce and failed to file a responsive pleading within the time allowed by the Utah Rules of Civil Procedure. Respondent is therefore in default.

The Temporary Emergency Order entered December 2, 2025, granting Petitioner sole physical custody and issuing a Writ of Assistance, is incorporated into this Decree as a permanent order of the Court.



The Court finds that Utah is the home state of the minor child pursuant to the Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA). The Court retains continuing and exclusive jurisdiction over custody matters concerning the minor child.

Respondent shall pay child support to Petitioner in the amount of **\$225 per month** for the support of the minor child, pursuant to Utah Child Support Guidelines and as calculated in the Child Support Worksheet filed with the Court.

Payments shall begin on the 1st day of the month following entry of this Decree and continue each month thereafter until further order of the Court.

Petitioner incurred attorney fees and costs in bringing this action. The Court finds it equitable that Respondent reimburse Petitioner for reasonable attorney fees and costs associated with this action. The amount of attorney fees may be determined upon motion supported by appropriate documentation.
