Additional provisions

29. The parties will adhere to the following additional provisions:

a.

Additional Provision: Equalization Payment – Division of Marital Property: 1. Payment Obligation: Joshua Allan Shelton shall pay Elizabeth Anne Shelton ten thousand dollars (\$10,000) as an equalization of marital assets. This payment shall be made in one lump sum no later than thirty (30) days after the filing of the fully executed Separation Agreement with the court. 2. Method of Payment: Payment shall be made by electronic transfer or certified check. 3. Effect of Payment: Upon receipt of the payment, Elizabeth Anne Shelton shall have no further claims against Joshua Allan Shelton for division of marital assets. Each party shall hold the other harmless from any claims related to the equalization of assets after the payment is made. 4. If Joshua Allan Shelton

fails to make the payment within the thirty-day period, he shall be responsible for any costs, interest, or attorney fees incurred by Elizabeth Anne Shelton to enforce this provision, and Elizabeth Anne Shelton may seek enforcement through appropriate Utah court of jurisdiction.

b.

Additional Provision: Health Insurance Provision: Joshua Allan Shelton shall maintain Elizabeth Anne Shelton on his existing health insurance coverage and shall not remove or cause Elizabeth Anne Shelton to be removed from said policy prior to thirty (30) days after the entry of the Decree of Divorce dissolving the parties' marriage. Joshua Allan Shelton shall continue paying all premiums necessary to maintain such coverage during this thirty-day period. No sooner than thirty (30) days following the entry of the Decree of Divorce, Joshua Allan Shelton may remove Elizabeth Anne Shelton from his health insurance policy. Thereafter, each party shall be solely responsible for obtaining and maintaining his or her own health insurance coverage. Elizabeth Anne Shelton shall be responsible for any continuation coverage available to her, including coverage under COBRA, and shall bear all costs associated with such coverage. Each party shall hold the other harmless for any medical expenses incurred after Elizabeth Anne Shelton's coverage under Joshua Allan Shelton's coverage terminates.

c.

Additional Provision: Cell Phone: 1. **Ownership and Responsibility:** Joshua Allan Shelton shall retain ownership of the marital cell phone account listed under his name. Elizabeth Anne Shelton shall continue to have access to the account until thirty (30) days after the filing of the fully executed Separation Agreement with the court, at which time Joshua Allan Shelton shall remove her access. 2. **Billing and Payment:** Joshua Allan Shelton shall continue to pay all charges associated with the account during this thirty-day period. After the thirty-day period, Elizabeth Anne Shelton shall be solely responsible for establishing and maintaining her own cell phone service at her expense. 3. **Cooperation:** Both parties shall cooperate to transfer or disconnect services as reasonably necessary to implement this provision. Each party shall hold the other harmless for any charges incurred after the termination of Elizabeth Anne Shelton's access to the account.

d.

Additional Provision: Prevailing Party -- Enforcement Provision: If either party is required to initiate court proceedings to enforce any provision of this Decree, the court may award reasonable attorney's fees and costs to the party

who substantially prevails in such action, unless the court finds that such an award would be inequitable under the circumstances after considering the financial resources of the parties and the reasonableness of the parties' positions. Utah Code §§ 30-3-3 and 30-3-5

Duty to sign documents

30. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
