THE ABOVE-ENTITLED MATTER having come before the Court by written stipulation of the parties and an affidavit of grounds and jurisdiction, with the Court having taken all matters herein under advisement and being fully advised in the premises, and having heretofore entered its Findings of Fact and Conclusions of Law, and for good cause appearing therefore, IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. **Residency:** Mr. Medel is a bona fide resident of Salt Lake County, State of Utah, and has been for three (3) months immediately prior to the filing of this action.

2. **Marriage Status:** The parties married on December 24, 2022,

in St. George, Utah. The parties are currently married. The parties separated on or about January 6, 2025.

3. **Grounds for Divorce:** During the course of the marriage the parties have experienced difficulties that cannot be reconciled and that have prevented the parties from pursuing a viable marriage relationship.

4. **Children:** The parties have no minor children, and none are expected.

5. **Real Property:** The parties have no real property to divide.

6. **Personal Property:** Personal property shall be divided as follows:

- a. **Bank Account:** The parties had a joint account at Navy Federal Credit Union. That account should be closed immediately and not used by either party.
- b. **2016 Kia Rio:** This vehicle was purchased by Kayson. There was a lien on this vehicle financed through American Credit Acceptance in Kayson's name only. The vehicle has been repossessed. There is a deficiency on the vehicle. Kayson will pay this debt and hold Cami harmless therefrom.
- c. **2013 Scion FRS:** This vehicle was purchased by Kayson. There is a lien on this vehicle financed through Navy Federal Credit Union in Kayson's name only. Kayson has this vehicle. Kayson will remain liable for

the debt on this vehicle and hold Cami harmless therefrom.

7. The remainder of the parties' personal property will be divided as is. Any premarital or post separation property shall stay the property of the person to whom it belongs.

8. **Retirement:** Kayson is formerly a member of the U.S. military and has a TSP and FERS retirement plan. As consideration for taking the debt associated with the Kia Rio, Kayson is awarded his entire retirement funds and Cami shall take nothing thereby.

9. **Alimony:** This is a marriage of short duration, and each party is capable of meeting their own needs. Neither party is awarded alimony now or in the future.

10. **Debts:** Other than the two vehicle debts listed above, the parties have no other joint debts. Both parties remain responsible for any post separation debts that they acquire or that are in their own name and will hold each other harmless therefrom. Neither party should acquire debt in the other parties' name.

11. **Public Forum:** Neither party will make statements about the other party in a public forum, including but not limited to social media.

12. **Entry of Decree:** Petitioner is awarded a Decree of Divorce from Respondent on the grounds of irreconcilable differences, the same to become final upon entry.
