Divorce

7. The parties do not need a court order about retirement money.


### Duty to sign documents

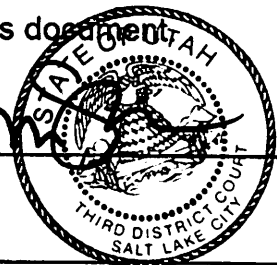
