The above-entitled matter came before the Court for a bench trial on March 11, 2026. Plaintiff Jennie Wingad was present and represented by attorney Stephen Florence. Defendant Amanda Alderson was present and represented by attorney William N. Pohl.

At trial, the Honorable Judge Daynes ordered that Defendant shall pay principal and prejudgment interest pursuant to the Plaintiff's claim, and the reasonable attorney's fees and costs incurred by the Plaintiff in bringing this action. An affidavit of those costs and fees has

been provided to the Defendant and filed with the Court. The Court hereby enters judgement against the Defendant and in Favor of the Plaintiff as follows:

1. Pursuant to the Plaintiff's claim of action in this matter, Plaintiff is awarded a judgment against the Defendant in the amount of \$33,280.88, which represents the principal sum of \$20,800.55 and prejudgment interest at the statutory rate of 10% per annum beginning February 28, 2020, through the date of this judgment.
2. The Plaintiff is awarded a judgment against the Defendant in the amount of \$22,217.95 for her reasonable costs and attorney's fees incurred in bringing this action.
3. The total judgment entered in favor of the Plaintiff and against the Defendant is \$55,498.83.
4. This judgment shall bear interest pursuant to Utah Code Ann. §15-1-4 at the statutory rate of 5.51% per annum from the date of entry until satisfied in full.
