Plaintiff's Motion for Renewal of Judgment as to Johnelle Taylor aka Floyd Johnelle Taylor was filed with the Court on March 24, 2026. Plaintiff's motion included the supporting Declaration of Richard C. Terry. Having considered the fully-briefed motion, the Court hereby finds that the facts in the supporting affidavit are accurate and that notice has been properly given.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED,
as follows:

1. Plaintiff's judgment as to Defendant Johnelle Taylor aka Floyd Johnelle Taylor dated March 30, 2018, is renewed for an additional eight years from the entry of this order or from the scheduled expiration date of the original order, whichever occurs first.

2. The amount now due and owing is as follows:

\$23,346.94 Judgment dated 03/30/2018 on First and Second Causes of Action,

9,692.01 Accrued interest on principal of \$13,621.71 from 03/28/2018 to 03/24/2026, at 8.9% per annum,

6,048.59 Judgment dated 03/30/2018 on Third and Fourth Causes of Action,

3,065.55 Accrued interest on principal of \$2,972.53 from 03/28/2018 to 03/24/2026, at 12.9% per annum,

435.00 Attorney fees to March 22, 2010,

255.00 Costs to March 22, 2010,

342.50 Post-judgment attorney fees from March 22, 2010, to March 28, 2018,

18.00 Post-judgment costs from March 22, 2010, to March 28, 2018,

767.50 Attorney fees from March 28, 2018, to March 24, 2026, and

385.50 Costs from March 28, 2018, to March 24, 2026

\$44,356.59 TOTAL JUDGMENT,

with interest accruing on the Total Judgment from March 24, 2026, at the respective contract rate until paid in full.

3. The judgment creditor is Cyprus Credit Union. The judgment debtor is Johnelle Taylor aka Floyd Johnelle Taylor. There are no assignors or assignees as this judgment has not been assigned.

4. A certified copy of the Judgment Renewal was recorded on April 9, 2018, with the Salt Lake County Recorder's Office as Entry No. 12749648, Book 10663, Page 2376-2380, creating a lien on the Defendant's real property in favor of Plaintiff.

IT IS FURTHER ORDERED that this renewed judgment may be augmented in the amount of reasonable costs and attorney's fees expended in collecting this renewed judgment. Said augmented renewed judgment shall be awarded based upon affidavit of Plaintiff's counsel and without further motion or notice to Defendant.
