Defendants, DAY FAMILY TRUST 1/19/2023 (the “Trust”), VALERI HEISE (“Ms. Heise”) and JUSTIN HEISE (“Mr. Heise) (collectively, the “Defendants”) having been served with process, and having failed to appear; the Default of Defendant, having been duly entered by the Clerk of Court on August 18, 2025, against the Trust and on August 19, 2025, against Ms. Heise and Mr. Heise; evidence having been introduced in support of the claims of Plaintiff SYNERGY WINDOWS OF SALT LAKE, LLC (“SW”); SW having filed its Motion for Default Judgment against Defendants on October 29, 2025 (the “Motion”); the Court having read and considered the Motion; having reviewed the evidence submitted therewith;

having considered the written arguments of counsel, and with the intent of rendering a decision on all remaining claims before the Court therefor;

IT IS HEREBY ORDERED that the judgment be, and hereby is, awarded to SW, and the SW shall recover from the Defendants as follows:

- (i) The outstanding amount owed/lienable amount to SW in the amount of Eighteen Thousand Eight Hundred Eighty-Nine Dollars and 00/100 (\$18,889.00);
- (ii) The attorneys' fees SW incurred in the amount of Three Thousand Eight Hundred Ninety-Nine and 00/100 (\$3,899.00); and
- (iii) The costs SW incurred in the amount of One Thousand Four Hundred Fifty-Five Dollars and 94/100 (\$1,455.94).

IT IS FURTHER ORDERED that judgment be, and hereby is, awarded to SW, and that SW shall recover from Defendants the sum of Twenty-Four Thousand Two Hundred Forty-Three Dollars and 94/100 (\$24,243.94). SW is also awarded post judgment interest at the statutory rate set forth in Utah Code § 15-1-4 beginning on the date the Judgment is entered, until fully paid, as well as any additional and/or actual attorneys' fees and costs incurred to collect the Judgment.

IT IS SO ORDERED.
