

This matter came before Commissioner Renee Blocher for a Hearing on February 17, 2026. Petitioner Cathy Elizabeth Knowlson ("Ms. Knowlson") was present, and was represented by her counsel, Daniel W. McKay who was also present. Respondent George Zachery Knowlson ("Mr. Knowlson") was also present.

IT IS HEREBY FOUND that:

1. A Hearing was held on February 17, 2026, to assess Mr. Knowlson's compliance with the Decree of Divorce (*docket entry 33*).

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED, as follows:

2. Pursuant to the February 17, 2026 Hearing, Judgment is hereby entered in favor of Ms. Knowlson against Mr. Knowlson as follows:

a. Child Support Arrearages

i. Ms. Knowlson is hereby entitled to a judgment against Mr. Knowlson for child support arrearages as a result of the February 17, 2026 Hearing.

1. Child Support Arrearages: \$7,722, representing \$858/month as ordered in the Decree of Divorce. (*see docket entry 64, ¶ 3*)

b. Medical Expenses

i. Ms. Knowlson is hereby entitled to a judgment against Mr. Knowlson for unreimbursed medical expenses as a result of the February 17, 2026.

1. Medical Expenses: \$730.45 (*see docket entry 64, ¶ 4*)

c. Attorney's Fees

i. Ms. Knowlson is hereby entitled to a judgment against Mr. Knowlson for partial attorney's fees and costs incurred in this litigation as a result of the February 17, 2026 Hearing.

1. Attorney's Fees: \$750.00 (*see docket entry 64, ¶ 11*)

d. Judgment Amount:

- i. Ms. Knowlson is awarded a Judgment and Order against Mr. Knowlson in the total amount of **\$9,202.45**, to bear interest at the statutory post-judgment rate of 5.51%.
