Defendants SHORELINE CONSULTING, LLC, and MICHAEL FISHER, who were properly served on May 5, 2025, have failed to appear and answer the Complaint on file herein within the time allowed by law, and the defaults of said Defendants have been entered according to law. Upon the application of Plaintiffs in this action and pursuant to Rule 55(b) of the Utah Rules of Civil Procedure, judgment is hereby entered against SHORELINE CONSULTING, LLC, and MICHAEL FISHER, pursuant to the prayer of the complaint.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. Judgment in favor of Plaintiffs and against Defendants Shoreline Consulting, LLC and Michael Fisher as follows:

1. Plaintiffs are awarded their reasonable attorney fees incurred in this matter. On or about January 12, 2026, Plaintiffs submitted to the court the Affidavit of Brooke Ashton supporting request for attorney fees pursuant to Rule 73(d) of the Utah Rules of Civil Procedure.

2. Post-judgment interest shall accrue at the rate of 5.51% per annum pursuant to Utah Code § 15-1-4 until the judgment is satisfied.

3. The 28-day waiting period in Utah R. Civ. P. 62(a) for execution on or enforcement of a judgment is waived as to this judgment.

4. Plaintiffs shall be entitled to augment this judgment for costs, expenses, or attorney's fees incurred in the collection of this judgment by submitting a declaration or affidavit establishing those amounts.

5. Defendants are liable for the third party judgment in favor of the Utah Labor Commission in the amount of \$6,030.02.

6. Defendant Michael Fisher shall be liable for any and all taxes owed by WNF Enterprises, including the fines, late fees and other penalties of said taxes.
