Alexandria Garcia (“Petitioner”) having filed an action against Jose Luis Reyes (“Respondent”) seeking a divorce in the above-titled court and, Jose having filed an Answer and Counterclaim, the matter having reached a final resolution through an in-person trial on September 17, 2025. The Court received evidence, took testimony, being fully apprised herein, **and the Court having previously entered its written Findings of Fact and Conclusions of Law;**

NOW THEREFORE IT IS HEREBY ORDERED, ADJUDGED,

AND DECREED AS FOLLOWS

1. DIVORCE: That the parties are granted a Decree of Divorce on the grounds of irreconcilable differences the same to become final upon entry.
2. JURISDICTION AND VENUE: The Court has jurisdiction over the parties and the subject matter of this action. Venue is proper in this Court.

3. REAL PROPERTY:

- a. The property located at 1276 W. CJ Way, West Valley City, Utah (the “Trailer Home”) is deemed real property for purposes of this Decree.
- b. The Trailer Home is marital property.
- c. The value of the Trailer Home for purposes of division is \$35,000, representing the 2021 valuation.
- d. The equity in the Trailer Home as of the 2021 valuation shall be divided equally between the parties.

4. ALIMONY:

- a. Neither party is awarded alimony now or any time in the future.

5. RETIREMENT BENEFITS:

- a. Petitioner possessed a retirement account with a value of \$8,658.84 at or near the time of separation.
- b. The retirement account is marital property.
- c. Respondent is awarded one-half of the value of the account as of separation.
- d. Petitioner shall pay Respondent the amount of \$4,329.42.

6. ATTORNEYS FEES: Each party shall pay their own attorney fees and costs incurred in this matter.

7. OTHER ORDERS:

- a. Except as expressly ordered herein, all other claims and requests for relief of either party are denied.
- b. All Findings of Fact and Conclusions of Law are incorporated herein by reference.
