The above-captioned matter having come before the above-referenced Court, the Court having reviewed the file and finding the necessary pleadings in the file, the Court having entered its Findings of Fact and Conclusions of Law, and being otherwise fully advised states:

**IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:**

Provisions Relating to Termination of Marriage

1. Emelita and Ryan were married in Salt Lake City, Utah, on April 20, 2024.
2. Emelita is awarded a divorce from Ryan on the grounds of irreconcilable differences and the marriage is hereby terminated.

#### Provisions Relating to Children

3. The parties have no minor children together and none are expected.

#### Provisions Relating to Alimony

4. Both parties are fully able to support themselves. Therefore, neither of them is awarded alimony.

#### Provisions Relating to Real Property

5. The parties do not have any real property.

#### Provisions Relating to Personal Property

6. Ryan is awarded the 2003 Chevrolet Silverado.
7. All other items of personal property should be awarded to the party currently in possession of those items.

#### Provisions Relating to Financial or Bank Accounts

8. Each party should keep their own accounts free and clear of any claim by the other party.
9. No joint assets are known to the parties but if any are discovered they should be divided 50/50.

#### Provisions Relating to Investment Accounts

10. Each party is awarded any stocks, bonds, or investment accounts that they may have free and clear of any claim by the other party.

#### Provisions Relating to Retirement Accounts, Plans, or Pensions

11. Each party is awarded their own retirement accounts, plans or pensions free and clear of any claim by the other party.

#### Provisions Relating to Debts

12. Neither party is allowed to incur new debts in the name of the other party.
13. Each party is awarded their own debts unless specifically mentioned herein.
14. No marital debt is known to either party. If marital debt is discovered and it was incurred prior to this agreement, the parties should split the debt 50/50.

#### Provisions Relating to Attorney's Fees and Costs

15. The parties should each pay their own attorney's fees and costs incurred in prosecuting this action.

#### Miscellaneous Provisions

16. Emelita is allowed to change her name to Emelita Nichole Diaz if she so desires.
17. Each party is ordered to execute and deliver to the other such documents as are required to implement the provisions of the Decree of Divorce entered by the Court.
