The court decrees:

### Divorce

1. Leobardo Guizar is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Leobardo Guizar. The divorce will become final upon entry of the divorce decree.

### Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
