Pursuant to the Court's Findings of Fact and Conclusions of Law, incorporated herein by this reference, and after having reviewed the documents in this matter and determined that the Stipulated Settlement Agreement between Petitioner and Respondent is fair and reasonable and after having been fully advised in the premises,

**IT IS HEREBY ORDERED AND DECREED AS FOLLOWS:**

1. **Jurisdiction, Marriage Relationship, and its Termination.** Anthony H. Flickinger is an actual and bona fide resident of the County of Tooele, State of Utah, and has been for more than three months immediately prior to the commencement of this action. Anthony H. Flickinger and Megan J. Flickinger are husband and wife, having been married on December 14, 2002 in St. George, Utah.

2. Anthony is awarded a Decree of Divorce from Megan upon the grounds of irreconcilable differences divorcing and dissolving all bonds of matrimony heretofore existing between Anthony and Megan. At the request of the Parties, the Decree of Divorce is entered Nunc Pro Tunc as March 11, 2009.

3. **Marital Children.** The parties have no minor children between them and none are expected.

4. **Award of Personal Property.** Each party is awarded all personal property currently in their possession.

5. **Order on Debts.** Each party is ordered to be responsible for those debts in their individual names and each party should be ordered to hold harmless the other therefrom, their own individual debts and obligations.

6. **Award Concerning Real Property.** The parties have no real property which needs division of the Court.

7. **Alimony.** Neither party is awarded any alimony, now or in the future.

8. **Financial Accounts.** Each party is awarded those financial accounts in their own name, free and clear of any claim from the other party.

9. **Retirement Accounts.** Each party is awarded those retirement accounts that they have accumulated in their individual names, free and clear of any claim of the other party.

10. **Attorney Fees.** Each party is ordered to assume and pay and hold harmless the other there from, their own attorney fees.
