supporting declaration, and for good cause appearing:

IT IS HEREBY ORDERED that:

1. Plaintiff's Motion for Default Judgment against Defendant B&D Trading Worldwide LLC d/b/a Controller Chaos is granted.
2. Plaintiff is awarded judgment against Defendant in the amount of \$60,400 for actual damages, plus pre-judgment interest at the rate of 10% per annum from February 14, 2024, until the date of this judgment.

3. Plaintiff may file a separate motion for attorneys' fees and costs incurred in prosecuting this action at a later date pursuant to the parties' agreement and applicable law.

4. Plaintiff is also awarded reasonable attorneys' fees and costs which may be incurred in collecting these amounts from Defendant pursuant to the parties' agreement.

5. This judgment resolves all claims asserted by Plaintiff against Defendant and is final pursuant to Rule 54(b) of the Utah Rules of Civil Procedure.
