9. The parties will adhere to the following additional provisions:

a.

Additional Provision: Fixed Dollar Award Charlene Marie Conner is awarded, and the Railroad Retirement Board is directed to pay, an interest in the portion of Phillip Scott Conner's benefits under the Railroad Retirement Act which may be divided as provided by section 14 of that Act. 45 U.S.C. § 231m. Charlene Marie Conner share shall be computed as an amount equal to zero dollars of Phillip Scott Conner's monthly divisible benefits.

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
