**FINAL DEFAULT JUDGMENT**

Pursuant to Rule 55(b)(1) of the Utah Rules of Civil Procedure, the Court hereby enters Judgment in favor of Plaintiff ODK CAPITAL, LLC, against Defendants J & L TOOLS DISTRIBUTOR LLC and JEFFREY LADD, jointly and severally, in the principal amount of \$14,197.21, plus pre-judgment interest at the statutory rate of 10% per annum, pursuant to Utah Code § 15-1-1, from August 14, 2025 through April 29, 2026 in the amount of \$1,003.53, attorneys fees in the amount of \$350.00, pursuant to URCP 73(f)(1), as the underlying agreement between the Parties provides for attorneys' fees in the event of default, and in compliance with Rule of Professional Conduct 5.4, for a total judgment of \$15,550.74, plus post-judgment interest at the legal rate of 5.51% from the date of judgment until paid, based on the following:

1. Defendants J & L TOOLS DISTRIBUTOR LLC and JEFFREY LADD have failed to appear or otherwise defend in this case;
2. Defendants have been served pursuant to Rule 4(d)(1).

It is further ordered that this judgment MAY be augmented in the amount of post-judgment interest at the legal rate of 5.51%, and reasonable costs and attorneys' fees expended in collecting said judgment by execution or otherwise as shall be established by affidavit, permitted by ruled and/or the law, and approved by the Court.

Defendants J & L TOOLS DISTRIBUTOR LLC and JEFFREY LADD are jointly and severally liable for this judgment.
