The court decrees:

**Divorce**

1. Olga L Terriquez is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Olga L Terriquez. The divorce will become final upon entry of the divorce decree.

**Children (Utah Code 81-6-101(7))**

2. **Olga L Terriquez and JESUS C Terriquez Bravo** do not have any children together.

**Personal property (Utah Code Title 81, Chapters 1, 4, 6, and 9)**

3. All personal property not addressed in the divorce should be divided as the parties have already divided it.

**Debts**

**Real property**

5. The parties do not have any real property that is marital property. The parties do not need a court order about real property.

**Alimony**

6. Neither party will pay alimony.

**Retirement money**

7. The parties do not need a court order about retirement money.

**Duty to sign documents**

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)

**Name after divorce**

9. **Olga L Terriquez** changed her name when the parties married. **Olga L Terriquez's** name will be **OLGA L ARROYO** after the divorce.





