DECREE OF DIVORCE

Petitioner, **LEALANI FALATEA** (hereinafter “Lealani”), by and through her counsel of record, Ally Jamerson of Fontenot Law, hereby submits the following Decree of Divorce from Respondent, **KINGSLEY SUAMATAIA** (hereinafter “Kingsley”). The court, having entered its Findings of Fact and Conclusions of Law, and now being fully advised in the premises, and for good cause shown, does hereby find and order the following:

DECREE OF DIVORCE

1. The parties shall be granted a Decree of Divorce, final upon entry, severing the bonds of matrimony heretofore existing between the parties upon the grounds of irreconcilable differences, pursuant to Utah Code Annotated § 81-4-405(1)(h).

GLOBAL SETTLEMENT

2. As a global settlement, for all property, assets, and alimony claims, Kingsley shall pay Lealani \$200,000.00 from his Charles Schwab 0101 account within seven (7) days of signing the Stipulation and Agreement. Lealani will provide information for the wire transfer through counsel.

REAL PROPERTY

3. During the course of the marriage, Kingsley acquired real property at 377 North 650 West, Lindon, Utah 84042. Kingsley's parents occupy this home and are jointly on the mortgage and title with Kingsley. Lealani is not on the mortgage or title of this home.

4. This property shall be awarded to Kingsley, free and clear of any claim by Lealani.

PERSONAL PROPERTY

5. Lealani shall be awarded her 2024 Ford Bronco, free and clear of any claim by Kingsley.

6. Lealani shall be awarded her two (2) dogs, free and clear of any claim by Kingsley.

7. Kingsley shall be awarded his 2022 Ram 1500 TRX, free and clear of any claim by Lealani.

8. The parties shall be awarded each of their own personal effects, premarital property, and separate property.

9. The parties have divided all other items of personal property and shall each be awarded all personal property currently in their possession.

FINANCIAL ACCOUNTS & RETIREMENT

10. Kingsley shall be awarded the following accounts, subject to the global settlement payment above:

- a. Charles Schwab 0101 – Schwab 1;
- b. Chase Bank 2543 – Checking;

- c. Chase Bank 6357 – Checking;
- d. Chase Bank 8099 – Savings;
- e. NFL Savings 401(k); and
- f. Any other accounts solely in his name.

11. Lealani shall be awarded the following accounts:

- a. Charles Schwab Alliance Brokerage;
- b. Charles Schwab Alliance IRA; and
- c. Any other accounts solely in her name.

12. The parties shall close the following accounts which have no balance:

- a. Chase Bank 5969 – Savings (Joint);
- b. Chase Bank 8590 – Checking (Joint); and
- c. Charles Schwab 5548 – Checking (Joint).

13. The parties shall work together to close any joint accounts and to remove the name of any party listed on an account which was awarded to the other party.

DEBTS AND OBLIGATIONS

14. The parties do not have any jointly held debts or obligations.

15. Each party shall be solely responsible for any debts held in their name.

16. Each party shall indemnify and hold the other harmless on any and all debts or obligations that they are ordered to pay.

17. Pursuant to Utah Code Annotated § 81-4-406(3)(b), the parties shall notify respective creditors or obligees regarding the court's division of debts, obligations, or liabilities and regarding the parties' separate, current addresses.

TAXES

18. The parties owe \$25,000.00 in taxes for the 2025 tax year. Kingsley shall be solely responsible for this amount and shall pay this within seven (7) days of signing the Stipulation and Agreement. Kingsley shall also be awarded any refunds.

RESTRAINING ORDERS

19. The parties agree that the Protective Order in Case No. 254906130 shall be dismissed, with prejudice, and the following restraining orders shall be entered:

20. Each party shall be restrained from committing, trying to commit, or threatening to commit any form of violence or harm against the other. This includes stalking, harassing, threatening, physically hurting, or causing any other form of abuse.

21. Each party shall be restrained from contacting or communicating with the other party, either directly or indirectly, except to effectuate the terms of this Decree of Divorce entered by the court.

22. Each party shall be ordered to stay away from the other party's home, work/school, and place of worship.

23. Lealani shall file a withdrawal of her Request for Protective Order within seven (7) days and shall attend a hearing if necessary. The parties stipulate that both parties may attend any required hearing via Webex.

ATTORNEY FEES & COURT COSTS

24. Each party shall be responsible for their own attorney fees and court costs.

MISCELLANEOUS

25. Lealani shall be allowed to take her maiden name, family name, or any other name should

she so choose.

26. Each party shall be ordered to execute and deliver to the other the documents required to implement the provisions of this Decree of Divorce entered by the court.

27. The parties shall sign all documents necessary to comply with this Decree of Divorce within sixty (60) days from the entry of this Decree. If a party fails to sign a document within sixty (60) days, the other party may ask the court to appoint someone to sign the document.
