Pursuant to Rule 55(b)(1) of the Utah Rules of Civil Procedure, the Court hereby enters judgment in favor of Plaintiff Firmco Financial, Inc., in the amount of \$26,618.73, plus interest, against Defendants Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC:

1. Defendants Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC have failed to appear or otherwise defend in this case;

2. Defendants Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC are not infants or incompetent persons;

3. Defendants Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC have been personally served pursuant to Rule 4(d)(1); and

4. The claim against Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC is for a sum that can be made certain by computation, plus interest, based on a Declaration of Sharan Stults from Fimco Financial, Inc. to wit:

General damages pursuant to contract	\$19,379.23
Attorney fees and costs for Plaintiff	\$7,239.50
TOTAL DAMAGES	\$26,618.73

5. Defendants Curtis M. Jeffery, Scapegoat Trucking, LLC, and Sanctuary Cove Insurance, LLC are jointly and severally responsible for the liability to Plaintiff.

And it is further ordered that this judgment may be augmented in the amount of post-judgment interest at a rate of 5.51% per annum, or at the highest interest rate allowable by law, until paid in full, and reasonable attorney fees and costs incurred in collecting and enforcing the judgment, such augmentation to take place in accordance with Rule 73, Utah Rules of Civil Procedure.
