13. The parties will adhere to the following additional provisions:

**Additional Provision: For purposes of federal, state, and local taxes, health insurance, and employment related benefits, the parties agree as follows: The parties shall be treated as married for the entirety of the 2025 calendar year. Each party agrees to cooperate in good faith to file any required tax returns for the 2025 tax year in a manner consistent with married status, including but not limited to Married Filing Jointly as mutually agreed. Effective January 1, 2026, the parties shall be treated as single individuals for all purposes, including but not limited to tax filing status, health insurance coverage, employment benefits, and government reporting. Each party agrees to execute any documents reasonably necessary to carry out the intent of this provision and to indemnify and hold the other harmless from any penalties, liabilities, or damages resulting from a violation of this provision.**

**Additional Provision: The parties acknowledge that they entered into a valid and enforceable Prenuptial Agreement dated [Nov. 11, 2023]. In the event of any conflict between this Agreement and the Prenuptial Agreement, the terms of the Prenuptial Agreement shall control.**

c.

**Additional Provision: Both parties agree that the cost and expenses shall be shared equally between them.**

### **Duty to sign documents**

14. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
