Divorce

Additional Provision: **FUTURE ASSETS: Petitioner anticipates receiving settlement proceeds estimated between \$300,000 and \$700,000 over approximately five years from a claim that arose prior to the marriage. Respondent acknowledges that said claim and any proceeds therefrom are Petitioner's sole and separate property, having been acquired prior to marriage. Respondent waives any and all present and future claims to said proceeds, regardless of when received.**

Additional Provision: **FUTURE TRUST: The parties acknowledge that Petitioner may create the Six Rose Living Trust in the future. Respondent waives any right to notice of such trust's creation and any claim to trust assets, including but not limited to any settlement proceeds placed into said trust. The parties agree that no trust currently exists.**

Duty to sign documents

10. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
