

This matter came before the Court on March 18, 2026 in regards to Petitioner's *Verified Ex Parte Motion to Enforce Order and for Sanctions*, which hearing was held before the Honorable Joanna Sagars, District Court Commissioner. Petitioner GRAEME MUTCHLER ("Petitioner") was present and represented by Wyatt A. Kirk. Respondent BRANDEE DEJONG ("Respondent") was present and represented by Wendy Bradford.

The Court HEREBY ORDERS:

1. A judgment shall be entered against the Respondent in the amount of \$16,000.00 to be paid within thirty (30) days from the date of the hearing. This deadline falls on April 17, 2026.

2. The parties shall return to the court for a Review Hearing on April 29, 2026 at 1:30 pm via Webex to ensure the judgment is satisfied.
3. The payment of \$16,000.00 resolves any and all current and past claims for all issues between the parties, including but not limited to extracurricular, school fees, contempt, sanctions, attorney's fees, insurance, medical expenses, interest, deposition costs, recorder costs, custody evaluation costs, etc. to present.
4. The sole issue of child support is being handled through ORS and will continue to be handled through ORS.
5. The parties stipulated that this is a resolution for all prior and pending court orders, motions and issues between the parties.
6. In the event the Respondent pays Petitioner \$16,000.00 prior to the pending hearing, the hearing shall be stricken.
