The court decrees:

Divorce

1. Estefania Santivanez is granted a divorce based on the Declaration of Jurisdiction and Grounds signed by Estefania Santivanez. The divorce will become final upon entry of the divorce decree.

6. Neither party will pay alimony.

### Retirement money

7. The parties do not need a court order about retirement money.

### Duty to sign documents

8. The parties will sign all documents necessary to comply with the divorce decree within 60 days from entry of the decree. If a party fails to sign a document within 60 days, the other party may ask the court to appoint someone to sign the document. (Utah Rule of Civil Procedure 70)
