**Divorce**

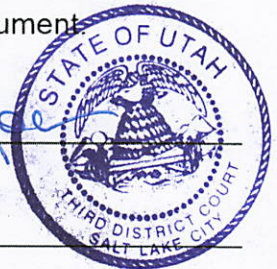
