

WHEREAS, on May 15, 2025, Plaintiff, Kitchen Winners NY Inc. ("Plaintiff"), moved (the "Motion") for an Order, pursuant to CPLR Section 3212, granting summary judgment in favor of Plaintiff [NYSCEF Doc. Nos. 82-92], as against the Defendants, David Triptow and TT Red Solutions, LLC, jointly and severally, in the amount of \$400,000.00, with pre and post-judgment interest at the statutory rate; awarding Plaintiff, and against the Defendants, David Triptow and TT Red Solutions, LLC, its reasonable legal fees incurred in connection with the collection and/or enforcement of the Guaranty; and granting such other and further relief as this Court deems just and proper.

WHEREAS, on May 30, 2025, Defendants, David Triptow and TT Red Solutions, LLC (collectively, "Defendants"), filed their opposition to the Motion [NYSCEF Doc. Nos. 93-103], and

WHEREAS, on June 5, 2025, Plaintiff filed papers in reply to Defendants' opposition papers and in further support of the Motion [NYSCEF Doc. Nos. 104-105], and

WHEREAS, after reading and considering Plaintiff's Notice of Motion, dated May 15, 2025, the Affirmation of Joseph Weiner, dated May 14, 2025, the Affirmation of Alexander Markus, dated May 14, 2025, the Statement of Material Facts, and the exhibits annexed thereto; the Affirmation of Aaron M. Schlossberg, dated May 30, 2025, the Affirmation of David Triptow, dated May 29, 2025, Defendants' Counter Statement of Material Facts, dated May 30, 2025, and Responses to Statement of Material Facts, dated May 30, 2025, Memorandum of Law in Opposition to Plaintiff's Motion for Summary Judgment, dated May 30, 2025, and the exhibits annexed thereto; the Affirmation in Reply of Alexander Markus, dated June 5, 2025, and the exhibits annexed thereto.



NOW, upon the application of Plaintiff, Kitchen Winners NY Inc., by its attorneys, Tamir Markus LLP, by Alexander Markus, Esq., it is


ADJUDGED, that in accordance with the Order, Plaintiff is granted judgment on its motion for summary judgment; and it is further ADJUDGED that the Judgment dated October 16, 2023 in the amount of \$539,835.00 (NYSCEF Doc NO. 59) is hereby vacated; and it is further ADJUDGED that the Plaintiff, with its place of business at 1134 53rd Street, Brooklyn, New York 11219, does have judgment and recovers, against Defendants, David Triptow, with an address at 1385 Sycamore Drive, Santa Clara, Utah 84765 and Defendant, TT Red Solutions, LLC, with its place of business at 1385 Sycamore Drive, Santa Clara, Utah 84765, jointly and severally, in the principal amount of \$400,000.00, plus interest at nine percent (9%) per annum from Defendants' breach of contract on February 23, 2021, in the amount of \$156,000.00.
