**3.** 3. Pursuant to Utah Code Ann. § 15-1-4(3), interest shall accrue on the principal and costs in the combined amount of \$106,354.61 at the legal post-judgment rate of 5.51% per annum, from the date of entry of this Judgment until paid in full.
